The meeting was called to order with President Joe Shatto reading of anti-trust statement.

SECRETARY'S REPORT

Motion #1 - A **motion** was made by President Elect Justin Ferrans to accept the Secretary's Minutes as published in the Tampa Bay Field Book. As there was no discussion on the motion, it was **seconded** by Jeff Kohler and passed unanimously.

TREASURER'S REPORT

Motion #2 - A **motion** was made by Secretary Chris Wild to accept the Treasurer's Report as published in the Tampa Bay Field Book. As there was no discussion on the motion, it was **seconded** by President Elect Ferrans and passed unanimously.

DIRECTOR'S REPORT

- Director Pete Mattson was unable to attend the May 15th Board Meeting however had the following to report:
 - Director Mattson's expenses are currently covered by his employer, not the chapter
 - Annual conference is approaching and early registration ends soon
 - The Education Conference will be held March 10-12, 2016
 - FSMS redistricting discussion has started – biggest concerns to address are in the Florida panhandle area

NEW BUSINESS

- **Nominations for Tampa Bay Chapter Executive Committee**

 - Nominations for the other positions were discussed – still open are Secretary, Vice-President and President Elect
- **FSMS Annual Conference**

- President Elect Ferrans requested \$300 for the BBQ cook-off

Motion #3 - A **motion** was made by Treasurer Dye to use \$300 of chapter funds for the conference BBQ. As there was no discussion on the motion, it was **seconded** by Jim Akker and passed unanimously.

Motion #4 - A **motion** was made by Jeff Kohler to sponsor the Board of Director's break for \$650. Secretary Wild suggested picking a more visible sponsorship. The motion was **amended** to sponsor the seminar CD's for \$750 with the Board of Director's break chosen as a backup sponsorship. The motion was **seconded** by Dan Ferrans and passed unanimously.
